Annual Baltimore Community Yard Sale Griley House Yard Space Registration

The Baltimore Area Chamber of Commerce sponsors the “Baltimore Community Yard Sale” the last Saturday of July each year. **Baltimore Area residents, organizations and businesses** may participate by simply having a yard, garage or sidewalk sale the day of the event. This year the Baltimore Community Yard Sales will be held **Saturday, July 31st, 2010, from 8:00am to 4:00pm.** The Baltimore Area Chamber of Commerce pays for advertising in newspapers in Fairfield County as well as all the counties touching Fairfield County.

Baltimore Area residents, organizations and businesses may lease space at the Griley House, 209 E Market Street, Baltimore, Ohio. This option is reserved for Baltimore Area residents, organizations or businesses that do not have a property or location within the Village of Baltimore limits.

- The spaces are approximately 10'x10'.
- The cost per space is \$15.00 and **MUST be paid prior to the date of the community yard sale** – you will NOT be allowed to setup at the Griley House if payment has not been received by Thursday, July 29th, 2010. Registration fee is non-refundable.
- Spaces are assigned on a first come first serve basis the day of the community yard sale.
- Spaces are available starting at 6:30am the day of the community yard sales and must be vacated by 5:30pm the day of the community yard sale.
- You must supply your own tables, chairs, tents, etc.
- No electrical connections are available.
- Event will be held rain or shine.

Items sold at the Griley House spaces must be “yard sale” type of items. Businesses may sell items that are typically sold by the business, including clearance items. Only non-profit organizations and farmers market type vendors may sell food or refreshments at the Griley House. Organizations selling food at the Griley House must provide proof of any required health department licenses, certificates, etc. Inclusions and exclusions are at the discretion of the BACC Baltimore Community Yard Sale Chairperson and/or BACC Executive Committee Officers and Board Members.
