Baltimore Area Chamber of Commerce 2010 Scholarship

The mission of the Baltimore Area Chamber of Commerce is to encourage, support and promote the businesses of the Baltimore Area.

The Baltimore Area Chamber of Commerce (BACC) is pleased to offer two (2) \$750 scholarships for the 2009-2010 academic school year. Please take note of the following guidelines:

1. The BACC Scholarship is open to all 2009-2010 school year graduating students at Liberty Union High School (LUHS) as well as all high school graduating students whose employer or parent's are members of the BACC.
2. The scholarship is intended for students planning on attending either a two year or four year accredited college or university located in Ohio, or any other institution accredited by the state and whose credits are fully transferable to an accredited four year institution.
3. The student must be carrying a minimum high school accumulative grade point average of 3.0.
4. A completed scholarship application, including supporting documentation and letters of reference **must be submitted to the BACC by Friday, April 23, 2010.**
5. The BACC Scholarship Selection Committee, made up of the BACC Executive Committee and Board, will select the scholarship recipients by Monday, April 30, 2010.
6. Special consideration will be given to applications that show financial need, students whose employer or parent's are BACC Members as well as student's who have been involved in extracurricular activities and community service that benefit the Baltimore Area Community.
7. BACC Scholarship recipients will be notified via mail by Wednesday, May 5, 2010.
8. BACC Scholarship recipients will be recognized at their respective school's award recognition program by a BACC representative.
9. BACC Scholarship recipients will be invited to attend the May Monthly Business Lunch Meeting on Tuesday, May 18, 2010, at 11:30AM.
10. The scholarship award will be disbursed to the recipient or institution of their choice upon presenting class enrollment confirmation to the BACC. Confirmation may be a printed statement or email statement from the institution of enrollment.
11. If the scholarship recipient fails to attend an approved college, university or other institution within one year of the award, he or she will forfeit the scholarship and it will be awarded to another student.
12. This is a one-time award. A student may receive this scholarship only once.
